EACH CHILD IN NOT ALONE, THROUGH A MENTORING AND NURTURING RELATIONSHIP WITH ONE OF COPTIC ORPHANS' MORE THAN 550 CHURCH-BASED VOLUNTEER REPRESENTATIVES, OR "REPS," RECEIVES THE PROTECTION, SUPPORT, AND CONFIDENCE THAT WAS LOST WHEN THEIR FATHER DIED OR ABANDONED THEM.
